

The MOF supervises state-owned enterprises under the MOF handling subsidies (donations) to non-government organizations and individuals in 2024.

1. According to article 6 and subparagraph 2, paragraph 1, article 7 of the Guidelines for Handling Subsidy (Donation) Budgets to Non-Government Organizations and Individuals by Central Government Agencies, competent authorities should formulate regulations for assessment of its subordinate agencies in handling subsidy (donation) business to non-government organizations and individuals, and publish the assessment results within 3 months after the end of the year.
2. In order to supervise the handling of subsidies (donations) to non-government organizations and individuals by state-owned enterprises under the MOF, and improve the efficiency of subsidy (donation) business, the MOF formulated “The MOF Guidelines for Supervision of State-Owned Enterprises under the MOF Handling Subsidies (Donations) to Non-Government Organizations and Individuals,” and requires state-owned enterprises under the MOF to strengthen their internal control systems. The MOF may select any of its state-owned enterprises for inspection of subsidy (donation) business when handling the inspection of the annual final account.
3. In 2024, state-owned enterprises under the MOF handled 69 items of subsidy (donation) to non-government organizations and individuals, with a total of NT\$317,533,864. The details are as follows:

Remark: The execution of subsidy (donation) budget to non-government organizations and individuals by state-owned enterprises is in accordance with their Directions for Budget Implementation.

4. In order to understand the internal control of state-owned enterprises under the MOF handling subsidies (donations) to non-government organizations and individuals in 2024, each state-owned enterprise should fill in the self-assessment form based on the spirit of corporate governance, annually audit its subsidy (donation) business, and report such performance to its board of directors (council). The MOF selected Land Bank of Taiwan Co., Ltd. (LBOT) for inspection of its subsidy (donation) business when handling the audit of the 2024 annual final account. LBOT allocated funds to Taiwan Foundation for Disaster Relief in 2024, and the information was not registered in the Civil Group Subsidy System within the prescribed time limit. The MOF made suggestions for LBOT to improve.
