

The MOF supervises state-owned enterprises under the MOF handling subsidies (donations) to non-government organizations and individuals in 2023.

1. According to article 6 and subparagraph 2, paragraph 1, article 7 of the Guidelines for Handling Subsidy (Donation) Budgets to Non-Government Organizations and Individuals by Central Government Agencies, competent authorities should formulate regulations about subsidy (donation) business to non-government organizations and individuals by its subordinate agencies, and make the supervision public within 3 months after the end of the year.
2. In order to supervise the handling of subsidies (donations) to non-government organizations and individuals by state-owned enterprises under the MOF, and improve the efficiency of subsidy (donation) business, the MOF formulated “The MOF Guidelines for Supervision of State-Owned Enterprises under the MOF Handling Subsidies (Donations) to Non-Government Organizations and Individuals,” and requires state-owned enterprises under the MOF to strengthen internal control system. The MOF may select any of its state-owned enterprises for inspection of subsidy (donation) business when handling the inspection of the annual final account.
3. In 2023, state-owned enterprises under the MOF handled 56 items of subsidy (donation) to non-government organizations and individuals, with a total of NT\$357,810,911. The details are as follows:

Remark: The execution of subsidy (donation) budget to non-government organizations and individuals by state-owned enterprises is in accordance with Directions for the Subsidiary Agencies Budget Implementation.

4. In order to understand the internal control of state-owned enterprises under the MOF handling subsidies (donations) to non-government organizations and individuals in 2023, each state-owned enterprise should fill in the self-assessment form based on the spirit of corporate governance, check subsidy (donation) business in the annual audit items, and report performance to its board of directors (council). The MOF selected Taiwan Tobacco & Liquor Co., Ltd. (TTL) for checking subsidy (donation) business when handling the inspection of the 2023 annual final account. TTL allocated funds to Miaoli County Charity Promotion Association and Yunlin County Mailiao Township Gongshe Opera and Cultural Development Association in 2023, and the information wasn't registered in Civil Group Subsidy System within the prescribed time limit. The MOF made suggestions for TTL to improve.
